Rebates will not exceed the installed job cost. Rebates for self-installed measures will not exceed the cost of materials.

**TO QUALIFY, EXISTING WINDOWS MUST BE SINGLE OR DOUBLE PANE WOOD/METAL OR METAL STORM WINDOWS. EXISTING VINYL WINDOWS DO NOT QUALIFY FOR REBATES. AN AUDIT OF EXISTING WINDOWS MUST BE COMPLETED PRIOR TO INSTALLING NEW WINDOWS. CALL CENTRAL LINCOLN PUD AT 1-888-883-9879 TO SCHEDULE AN AUDIT. AN INSPECTION OF THE INSTALLED WINDOWS MUST BE PERFORMED AFTER INSTALLATION. ONCE THE WORK IS COMPLETE, CALL 1-888-883-9879 TO SCHEDULE AN INSPECTION.**
