Program Eligibility

- ◆ **Single-family and multi-family residence must have a permanently installed electric heat system capable of heating the entire dwelling.**
- ◆ Central Lincoln PUD reserves the right to inspect completed work. Rebates will be paid only on work that meets Central Lincoln PUD specifications. If not familiar with specifications please contact us.

Qualifying Energy Efficiency Improvements

Weatherization rebates apply only to upgrades on existing homes, not new construction. The following energy efficiency improvements qualify for a rebate:

- ◆ Insulation (Attic, Under Floor, Wall)
- ◆ Duct Sealing – Work Must be done by a PTCS certified technician

When work is complete, contact Central Lincoln PUD at 1-888-883-9879 to schedule an inspection.

Rebate requests must be submitted within 6 months after purchase

Rebates - Subject to Availability of Funds

◆ **Insulation:**

- ◆ Attic Insulation Existing is less than R-11 increased to Minimum R-38 - \$0.50 per sq/ft
- ◆ Attic Insulation Existing R-11 – R-19 increased to Minimum R-38 - \$0.20 per sq/ft
- ◆ Floor Insulation Existing R-11 or less increased to Minimum R-30 - \$0.50 per sq/ft
- Wall Insulation Existing R-0 increased to Minimum R-13 - \$0.50 per sq/ft

- ◆ **Duct Sealing** – Rebate is \$450. Rebate is for site-built homes. Pressure guided duct sealing must meet PTCS requirements and be performed by a PTCS certified technician. A copy of the PTCS Duct Sealing Certificate & NW Duct Sealing Form must accompany this application
