Central Lincoln PUD Director Election/November 2, 2010

Subdivisions 1, 2, and 5 Director seats:

Subdivision 1: Newport. Much of the City of Newport. District territory due north of Yaquina Bay to the Agate Beach Subdivision.

Subdivision 2: Toledo/Siletz/Depoe Bay. District territory in Toledo, north to the city of Siletz, and northwest including the city of Depoe Bay, and the communities of Otter Rock and Lincoln Beach. Includes a portion of the Bittler Precinct.

Subdivision 5: Reedsport. All District territory in coastal Douglas County, including Gardiner, and the city of Reedsport; and in Coos County, the Lakeside, Hauser, and Glasgow areas heading south to the northern portion of North Bend.

Candidates' timeframe to file

(Must be done with Lincoln County Clerk, regardless of where in District candidate resides)

Thursday, July 15- Tuesday, August 24

Voters' Pamphlet deadline

(Voluntary. It costs \$100 to place a statement in the Lincoln County's Voters' Pamphlet, and the Douglas County Voters' Pamphlet. Coos County does not produce a voters' pamphlet. Also, due to state law, special district candidates are not allowed to place statements in the State Voters' Pamphlet)

Campaign Form Information:

All candidates must file a SEL 190 “Filing of Candidacy for Special District Nomination” form with the Lincoln County Clerk’s office in Newport, either in person or by mail at: 225 West Olive Street, Room 201, Newport, OR 97365

Candidates may file either by paying a \$10 fee, or by obtaining 25 valid signatures.

Campaign Finance Information:

It is very important that candidates review the state’s “2010 Campaign Finance Manual” at http://www.sos.state.or.us/elections/publications/campaign_finance/index.html

If a candidate expects to **raise more than \$ 350** for his or her campaign, he or she needs to file an SEL 220 “Statement of Organization for Candidate Committee” form, and a SEL 223 “Campaign Account Information” form with the Secretary of State’s office.

If a candidate expects to **raise less than \$ 2,000** for his or her campaign, he or she needs to file a PC 7 “Certificate of Limited Contributions and Expenditures” form with the Secretary of State’s office.

If a candidate expects to **raise more than \$ 2,000 for his or her campaign, he or she must create an ORESTAR account online** with the Secretary of State’s office.
